Procedures for Admission and registration of children

Payment for weekly child care is to be paid the beginning of each week the child is attending , we will expect that all payments be made. Other arrangements made be made by the director.

Smoking, Tobacco & Other Prohibited Substances

Parental Access

Child care facilities shall assure that the parent has welcome access to the child care facilities at all times. Welcome access shall be defined as a parent having access to areas of the facility available to his/her child and **non-disruptive** to normal daily activities.

Head Lice

When Head lice is discovered we will notified the parent of such condition. Children will all be check at that time. If your child is to have head lice we would ask that you remove your child and show proof that treatment has been done.
